## Item No. 01. Approval for previous proceeding.

**Discussion:** The meeting of IQAC was called on 15/06/2021, on 1: 30 p.m at IQAC Hall. Dr. Aware D. V. read the last proceeding. Dr. Kadam C.A proposed the motion of approval of the proceeding which was supported by the cell member Dr. A. M. Shaikh.

**Decision:** It was resolved that the previous proceeding is correct and to be accepted.

# Item No. 02: Discussion on Indoor Stadium Academic year 2021-22

**Discussion:** The cell members took up the Indoor Stadium issue in the meeting. During the discussion it was said that our college is a premiere institute in Newasa tehsil that has been serving to local community, offering degrees in diverse faculties.
